Donor Impact Report 2018



I am delighted to introduce the latest Brasenose College Donor Impact Report; my fourth as Principal. In my inaugural introduction back in 2015, I wrote of how in my first few months at BNC I had been astounded by the depth and warmth of feeling towards the college by its alumni and friends. This has only grown year-on-year and is most evident in the consistently growing number of you choosing to support BNC financially.

We received donations from over 1,000 of you in the last year – a remarkable figure – with gifts from alumni, current students, Fellows past and present, and also from organisations, trusts, foundations and friends. Thank you all for your astounding generosity and support.

The last year has proven to be an especially exciting one for philanthropy at BNC. The college's Annual Fund (which supports students throughout their time at BNC) topped £500,000 for the first time, and of course the completion and subsequent grand opening of The Greenland Library was a true highlight. I do hope you enjoyed reading the full report of the library opening in the most recent edition of the Brazen Notes. We truly are incredibly lucky to have such supportive alumni and friends. Rest assured, not a penny is wasted and not a penny goes unnoticed.

There are many heart-warming stories to be read in this report. We are most grateful to our donors, who will share with you why they choose to give to BNC, and also to some of our fantastic students, who have been beneficiaries of your support.

If you have given this year, thank you once again. I do hope to welcome you back in the near future so that you can see what a difference such gifts make to life at College.

Financial Review

At 31st July, 2017, the endowment was valued at £138.8m. The portfolio has benefitted from strong capital markets and from the expert advice of the alumni on the Investment Advisory Committee. The result has been investment gains of £33.0m in three years, and an annualised return of 11.3%. The college draws down 3.5% each year (calculated on a five year rolling average) and this transfer supports over one third of its operating costs.


Philanthropic gifts support the rich variety of college life including Fellowships, student bursaries, graduate scholarships and capital projects such as the expansion of Lecture Room XI. Most donors support the college through the Annual Fund, which exceeded £0.5m for the first time in 2017.

In April 2017, Brasenose took advantage of the historically low interest rates to raise finance by issuing £20m of unsecured loan notes with a fixed rate of 2.62%, repayable in 2057. This will fund the college's plans to expand student accommodation at Frewin and on the edge of the sports ground (subject to planning permission). The balance of the funds not required for the student accommodation will be invested in the endowment.

The underlying operational finances of the college remain healthy. Income was almost £11.0m and costs were £10.3m, leaving a surplus of £0.7m. Further analysis of the income and expenditure is depicted in the accompanying charts.



Gifts can be made as a one off, or by monthly or annual instalments over a period of up to five years. Anyone giving £1,509 or more within one year will be invited to join The 1509 Society. The Society was established in 2015 to recognise BNC's most generous and loyal donors.

"The library at BNC was the place from where I launched my career as a mechanical engineer over forty years ago. The study of physics led me to working on the integrity, ageing and failure of structures such as those found on nuclear plants and offshore installations. I still use the knowledge of materials, mechanics and heat transfer gained while I was at BNC in my job today as a Consultant Engineer at the Welding Institute and the University of Strathclyde, where I am a Visiting Professor, after spending earlier years in technical roles with Rolls Royce and the UK Atomic Energy Authority.

Your Donations in Action

In the summer of 2017 I was lucky enough to spend two months carrying out research in Townsville, Australia, thanks to the generous support of the Annual Fund. Conducting the research for my Final Honour Schools Project, I investigated the effects of climate change on *Drosophila* and their parasitoids in tropical forests, areas which are strongly impacted by global warming. Insects make up a huge part of tropical ecosystems, and it is critical to improve our understanding of their responses to rising temperatures, and how they affect the other species around them.

Working in collaboration with James Cook University, I was able to use their laboratories to design and plan my experiments, which I carried out in the nearby Paluma rainforest. Experiencing Australia and its rainforest first-hand was incredible, with a huge diversity of

wildlife on my doorstep. Blue-faced Honeyeaters, birds commonly seen around the university campus, and leaf-tailed geckos, incredibly well camouflaged but occasionally spotted clinging to the trees, were some of my favourites.

I found conducting my first piece of independent research to be a hugely rewarding experience. Being able to spend two months in Australia allowed me to collect the necessary data to analyse and write up my research for my Finals submission, and gave me a real insight into the joys and challenges of academic research.

I am hugely grateful to the Annual Fund for the support which enabled me to carry out this research, to enhance my studies, and to experience such a biologically diverse landscape.
